Unpacking

Although your PO-6106 is neither complicated nor difficult to operate, we recommend you take a few minutes to read this brief manual and familiarize yourself with the important information regarding product features, setup and operation.

As with most electronic devices, we strongly recommend you retain the original packaging. In the unlikely event the product must be returned for servicing, the original packaging (or reasonable equivalent) is required.

Installation

Environment

Never place this product in an environment which could alter its performance or reduce its service life. Such environments usually include high levels of heat, dust, moisture, and vibration.

- 1. Read these instructions.

- INPUT MONITORING


Input peak LED monitoring.

Operation

- 1. Make certain that speakers and input sources are properly connected before turns on.
- 2. Keep volume levels turned down before switching on.

*NOTE : The system's operation is delayed by approximately three seconds after pressing the power switch. This is due to the built-in protection circuitry, designed to protect the speakers and other system components.

Front Panel



1. INPUT PEAK INDICATOR

This LED lights to indicate the input level is too high.

2. OUTPUT INDICATORS

These LEDs indicate signal on their associated outputs.

3. POWER INDICATOR

When the unit is on, this power indicator LED is lit.

4. INPUT LEVEL CONTROL

This knob provides continuous control of the input level.


5. OUTPUT LEVEL CONTROL

This knob provides continuous control of the output level for each of the six outputs.

6. POWER SWITCH

This switch is used to turn the unit ON/OFF.

1. LINE INPUT

Line-level input on balanced XLR connector.

2. LINE OUTPUTS 1-6

Line-level outputs on balanced XLR connector.


3. AC POWER INPUT

Connect a standard three-pin AC cable to this connector.


4. DC POWER INPUT

These terminals are provided for the connection of DC battery power. Connect a 24V DC battery source to these terminals. Make certain the red terminal is connected to the battery's positive (+) side, and the black terminal to the battery's negative (-) side.

Block Diagram


